## Taste of the Central Valley

The Central Valley Rails to Trails Foundation (CVRTF) was formed to create a 27-mile trail along an inactive rail line, the Central California Traction Company Rail Corridor (CCT). Linking the counties of Sacramento and San Joaquin, the proposed trail will provide a safe route for non-motorized recreation and commuting. CVRTF's project is widely endorsed by local recreation agencies, local businesses, community organizations, and property owners along the CCT. The owners of the corridor, Union Pacific and BNSF Railroad companies, are presently exploring their options for the Corridor's usage. CVRTF believes the CCT has a bright future – as a trail!

CVRTF is a non-profit 501(c)(3) all-volunteer organization (Federal ID#94-3375724). Contributions to CVRTF are tax deductible to the extent allowed by State and Federal law.



TrailFest is CVRTF's annual fundraising event, providing resources to cover the Foundation's modest operating costs, along with donations to local charities. In 2009, TrailFest was attended by over 250 Central Valley residents who gathered under a huge tent to enjoy locally produced wine, beer and gourmet food. The event was a great success, and allowed the Foundation to support four local elementary school science camp programs. Proceeds from this year's event will benefit the Firefighters Burn Institute ([www.ffburn.org](http://www.ffburn.org)) and Project R.I.D.E ([www.projectride.org](http://www.projectride.org)).
